- (c) The Party/Parties will not hold the personnel of HKMC and the mediator liable for any claims, loss or damages in relation to the outcome or proceedings of the dispute under HKMC Mediation Rules.
- (d) The Party/Parties has/have read the 'Personal Information Collection Statement' and confirm/ confirms the agreement to provide personal data in relation to HKMC on a voluntary basis and on the terms and for the purpose set out in the Statement.
- (e) The Party/Parties understand and agreed that the mediator(s) of HKMC offer a one-off mediation service of no more than 4 hours.
- (f) The Party/Parties further confirms/confirm that the information provided in this Free Community Mediation Service Application form is true and accurate.
