She has conducted live supervision of Family Mediation for over 100 trainees including lawyers and counsellors. She has coached over 154 sessions of General and Family Mediation Training Courses and CPD programmes approved by the HKMAAL, HKIAC and the Law Society of Hong Kong since 2000. She has also conducted Mediation CPD programmes approved by the HKIAC & the HKMAAL as well as Mediation Training in different social services agencies, governmental departments, corporates and educational institutes in HK, the Mainland and Macau since 2007. She was a member of Accreditation and Training subgroup under Department of Justice in 2009, and a Committee Member of Hong Kong Mediation Council from 2009 to 2014.
