Under the global trend of driving growth through innovation, staying on top of the latest IP development and effective IP protection and exploitation strategies is key to making a head start.

This year's Symposium will cover the latest updates on IP in the Mainland, Hong Kong and Macao, and focus on the analysis of the crucial role IP plays in driving the economic development of the society in the 14th Five Year Plan Period, upon the announcement of the "Outline of the 14th Five-Year Plan for National Economic and Social Development of the People's Republic of China and the Long-Range Objectives Through the Year 2035" in March this year. There will also be case sharing to explore ways to foster enterprises' innovative development through effective IP protection and strategy.

- (2) Intellectual Property Protection and Portfolio Management in the 14th Five Year Plan Period
