International Professional Mediation Coach **Training Course**

Mediation Training Course is designed on performance-based approach to balance the teaching and practice of mediation concept and skills with designated role play exercises. Mediation Coach is one of the key participants in ensuring the high standard of our mediation training to enable the participants to receive credit towards professional mediator accreditation.

Being a Mediation Coach, he/she is expected to observe and guide role plays, to identify the areas for reinforcement and improvement of those participants of International Professional Mediator Training Certificate Courses as well as General Mediator Training Courses. Coaches will give feedback with reference to their performance in the role plays with a systematic feedback approach. Moreover, he/she is required to provide written feedback on the performance of the mediator trainee in the role-play according to the standard specified by Academy of International Dispute Resolution & Professional Negotiation ("AIDRN") Kong Mediation Accreditation Association Limited ("HKMAAL"). The objectives of this program are to explain the latest requirements of these two professional accreditation bodies. Participants will have the chance to understand mediation practice and latest development in the mainland. They will also be trained on how to effectively handle cross-border disputes. (Participants who have satisfactorily completed the course will be qualified to apply for the International Accredited Professional Mediator Panel (IAPM) of the International Dispute Resolution & Risk Managment Institute ("IDRRMI").)

Assessment

Stage 2 - Practicum

After completing stage 1, participants will be granted in-class assess to practice professional coaching with real-time coaching sessions (total 5 hours). They are required to perform in two coaching sessions as a professional coach trainee. Only when achieved satisfactory performances in the practicum sessions are eligible to obtain the professional certificate.

Certificate

- Certificate of Completion will be presented to participants who have attendance of 100% in stage 1 sessions.
- Certificate of Attendance will be presented to participants who have attendance of 70% or above in stage 1 sessions.
- Certificate of Accredited International Professional Mediation Coach will be presented to graduates who have attendance of 70% or above for all the sessions and have achieved satisfactory results in the assessment and completed the practicum phase.

- A. Selection will be made on the basis of applicants' mediation experience, training experience of mediation related course(s) and other mediation related experience.
- B. Registration must be made by returning the completed enrolment form via google link and CV and the crossed cheque or copy of bank-in slip to Room 506, 5/F, West Wing, Justice Place, 11 Ice House Street, Central, Hong Kong by 12:00 noon on 14 March 2022. Confirmation will be notified by email upon successful registration on or before 16 March 2022. No refund will be arranged at all circumstances after 16 March 2022.
- C. If you do not receive any email confirmation from the Secretariat after 16 March 2022, your name will be on waiting list. Your submitted cheque will be voided subsequently by the Secretariat if you have not been assigned a place in the captioned course. If your course fee was made by bank transfer, a cheque will be issued to you as the refund.
- D. Under the requirement of HKMAAL, a qualified Coach should have conducted at a minimum of 5 mediation cases or 50 mediation hours as a mediator within 3 years prior to the date of course approval.
- E. Participants must sign in and sign out. Participants who are late for more than 20 minutes or leave earlier in each session will not be qualified for the completion of IDRRMI's, HKMC's & MHJMC's CPD Points in respective sessions.
- F. If you are not able to attend the captioned course upon receipt of the confirmation email, you are required to inform the Secretariat as soon as you are aware of your unavailability on / before the course date by email. No refund will be made after confirmation.
- G. The assessment session will be video recorded for the sole purpose of performance evaluation.
- H. If typhoon signal no. 8 or above or black rainstorm warning signal is hoisted and not lowered by 2 hours before the class starts, the class will be postponed or cancelled. Rescheduled date / time / venue will be announced in due course.
- I. AIDRN reserves the right to accept / reject the registration and make the final decision of the course.
