# Professional Mediation Specialist Certification Training Course

## Intellectual Property Mediation Specialist

### Objective:

As a mediator, resolving Intellectual Property (IP) mediation cases requires adequate IP knowledge in classifications, concepts, and specific handling techniques. This course provides an overview of Intellectual Property law, patents, trademarks, copyrights, and technology transfer. It explores the fundamental concepts of these laws and how they interrelate with each other. Through case sharing and roleplay exercises, participants will be able to reinforce their competence in resolving IP mediation cases in both Hong Kong and overseas.

Upon successful completion of the course and passing the end-of-course assessment, participants will be eligible to be enlisted on the Mediation Specialist Panel, specific for the Intellectual Property mediation of the Hong Kong Mediation Centre (HKMC) or/and International Dispute Resolution and Risk Management Institute (IDRRMI).

## Certificate:
