With this Certificate, students can apply directly with the Hong Kong Mediation Accreditation Association Limited (“HKMAAL”) for attempting accreditation. Successful accreditation will lead to qualification of “General Accredited Mediator” and be listed on the panel of the HKMAAL. Applicants who attempt Accreditation of the HKMAAL must have at least 3 years full-time working experience.
